1 Plaintiffs White Pine County, Great Basin Water Network, Central Nevada Regional  
2 Water Authority, Sierra Club, Baker Water & Sewer General Improvement District, Utah  
3 Physicians for a Healthy Environment, Utah Rivers Council, Utah Audubon Council, and League  
4 of Women Voters of Salt Lake, Utah (collectively, “Plaintiffs”) hereby move for summary  
5 judgment pursuant to Rule 56 of the Federal Rules of Civil Procedure and Local Rule 56-1 of the  
6 Local Rules of Practice for the United States District Court for the District of Nevada. For the  
7 reasons fully set forth in the accompanying Memorandum in Support of Motion for Summary  
8 Judgment, Plaintiffs are entitled to summary judgment as a matter of law. Defendants  
9 (collectively, “BLM”) have granted to Defendant-Intervenor Southern Nevada Water Authority  
10 (“SNWA”) a right of way for construction of a pipeline to serve SNWA’s Clark, Lincoln, and  
11 White Pine Counties Groundwater Development Project in contravention of BLM’s duties under  
12 the National Environmental Policy Act (“NEPA”), 42 U.S.C. §§ 4321 et seq., the Federal Land  
13 Policy and Management Act (“FLPMA”), 43 U.S.C. §§ 1701 et seq., the National Historic  
14 Preservation Act (“NHPA”), 16 U.S.C. §§ 470 et seq., and implementing regulations established  
15 pursuant to NEPA, FLPMA, and NHPA.

19 Accordingly, Plaintiffs respectfully request that this Court grant Plaintiffs’ Motion for  
20 Summary Judgment and issue an order:

- 21 (i) Declaring that BLM’s FEIS and ROD violate NEPA, FLPMA, NHPA, and  
22 regulations promulgated thereunder;  
23  
24 (ii) Declaring that the BLM’s failure to prepare a Supplemental EIS violates NEPA;  
25  
26 (iii) Setting aside BLM’s actions;  
27  
28 (iv) Voiding the validity of the right-of-way pending BLM’s full compliance with  
NEPA, FLPMA, NHPA, and regulations and policies promulgated thereunder;

1 (v) Suspending and enjoining any operations on the right-of-way and order any  
2 facilities built on the right-of-way to be immediately removed and remediated;

3 (vi) Retaining continuing jurisdiction of this matter until BLM fully remedies the  
4 violations of law complained of herein;

5 (vii) Awarding Plaintiffs their fees, costs, and other expenses as provided by applicable  
6 law; and

7 (viii) Granting Plaintiffs such further relief as may be requested subsequently by  
8 Plaintiffs or as may be deemed by the Court to be just, proper, and equitable to remedy the  
9 violations of law complained of herein.
